## ordinance no. €-76-14

AN ORDINANCE AMENDING SECTION 4.16.02 AND SECTION 4.16.03 OF CHAPTER 4.16 OF THE CONWAY MUNICIPAL CODE: DECLARING AN EMERGENCY: AND FOR OTHER PURPOSES:

BE IN ENACTED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1. Section 4.16.02 of Chapter 4.16 of the Conway Municipal Code is hereby amended, which said Section 4.16.02 of Chapter 4.6 shall be amended to read as follows:

4.16.02 License Fees: The annual license fee to engage in or conduct the business of keeping, maintining and operating merchandise venidng machines, operated or activated automatically by the insertion therein of a coin or token of value, for the vending and distribution at retail of goods, wares and merchandise, including, but not limited to, confections, gum, nuts, cigarettes, tobacco, foods, soft drinks, papers and other articles for human use or consumption, shall be as follows:

ONE to FIVE merchandise vending machines	\$ 2.50
SIX to TEN merchandise vending machines	5.00
ELEVEN TO FIFTEEN vending machines	$10.00 \\ 20.00$
SIXTEEN TO TWENTY FIVE vending machines	20.00
TWENTY SIX or more vending machines	40.00

Section 2. Section 4.16.03 of Chapter 4.16 of the Conway Municipal Code is hereby amended, which said Section 4.16.03 of Chapter 4.6 shall be amended to read as follows:

4.16.03 License Fees: The annual license fee to engage in or conduct the business of keeping, maintaining, and operating service vending machines, operated or activated automatically by the insertion therein of one or more coins or tokens of value, for the rendering of service, including, but not limited to, weighing machines, toilet locks, and parcel lockers for the checking or storing of luggage, parcels or other articles, but excluding coin box telephones, and United States postage stamp vending machines, shall be as follows:

ONE TO FIVE service machines at any one location	\$ 2.50
SIX TO TEN service machines at any one location	5.00
ELEVEN TO TWENTY machines at any one location	10.00
TWENTY ONE TO THIRTY at any one location	15.00
THIRTY ONE TO FORTY at any one location	20.00
FORTY ONE OR MORE at any one location	25.00

Section 3. EMERGENCY CLAUSE: Therefore, an Emergencey is hereby declared to exist and this ordinance being necessary for the immediate protection of the public peace, health and safety shall take effect immediately upon its passage and approval.
