

ORDINANCE NO. 0-78-14

WHEREAS, R.F.Kordsmeier; Felix Moix, Sr.; Virgil Moore; Louis R. DeMarco; Joe Favre; Charles D. Ward; Edmund Moix; Gerald Kordsmeier; Stepehn A. Hofherr; Fredric R. Moix; Loretta Holder; T.L. Yielding and Jess E. Baker being the owners of the hereinafter described lands, did petition the County Court of Faulkner County, Arkansas for an order annexing said lands and territory to the City of Conway, Arkansas; and ,

WHEREAS, after proceeding being had upon notice by publication , all as provided by law and in accordance with the laws of the State of Arkansas, the Judge of the said County Court did, on the 22 day of Feb., 1978, enter his order of annexation to said City of the hereinafter described lands:

NOW, THEREOFRE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That the City Council of Conway, Arkansas, does hereby accept the hereinafter described lands and territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 22nd day of February 1978, said territory being described as follows: to-wit:

Property in the Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14, T5N, R14W, Faulkner County, Arkansas , to be annexed to the City of Conway:

Part of the Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14, T 5N, R14W, Faulkner County, Arkansas, described as follows: Beginning at the Northeast Corner of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14; thence running West to the Northwest Corner of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14; thence running South 522.7 ft; thence running East 2,262.8 ft. to a point 377.2 feet West of the East line of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14; thence running South 797.3 feet to the South line of the Northeast Quarter (NE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14; thence running West 282.8 ft; thence running South 792 ft; thence running East 660 ft to the East line of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14; thence running North 2,112 ft. to the point of beginning. Less and except the following two tracts of land which are already a part of the City:

TRACT NO 1: Beginning at a point on the North line of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14, a distance of 669 ft. West of the Northeast Corner of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14; thence running South 522.7 ft; thence running West 321 ft; thence running North 522.7 ft; thence running East 321 ft to the

point of beginning.


TRACT NO. 2: Beginning at a point on the North line of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14 at a distance of 1,042.5 ft West of the Northeast Corner of said Southeast Quarter (SE $\frac{1}{4}$) of Sec. 14; thence South 522.7 ft; thence West 247.5 ft; thence North 522.7 ft; thence East 247.5 ft., to the point beginning.

and thatsaid lands and territory be, and the same hereby are declared to be a part of the City of Conway, Faulkner County, Arkansas.


