

ORDINANCE NO. 0-90-5

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: The City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 2nd day of February, 1990, and said territory being situated in Faulkner County, Arkansas, and described as follows:

A part of the West 1/2 SE 1/4, Section 20, T5N, R13W, described as beginning at a point 210 feet south 00 degree 03 minutes east of the northeast corner of said West 1/2 SE 1/4; thence west 228.56 feet; thence south 00 degree 03 minutes 40 seconds east 210 feet; thence east 228.52 feet to the east line of said West 1/2 SE 1/4; thence north 00 degree 03 minutes west 210 **feet** along said east line to the point of beginning, containing 1.10 acres, more or less, subject to a 25 foot road easement on the west side.

Also, a part of the West 1/2 SE 1/4, Section 20, T5N, R13W, described as beginning at the northeast corner of said West 1/2 **SE** 1/4, run thence west 228.6 feet; thence south 00 degree 03 minutes 40 seconds east 210 feet; thence east 228.56 feet to the east line of said West 1/2 SE 1/4; thence north 00 degree 03 minutes west 210 feet along said east line to the point of beginning, containing 1.10 acres, more or less, subject to county road easement along the north side and contains a 25-foot road easement along the west side.


and that said above-described lands and territory be, and the same hereby **are**, declared to **be** a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2: **From** and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges **of**, and be subject to all the laws, rules, ordinances, limitations, and regulations imposed upon the inhabitants within the original limits of said City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as a part of Ward 4 of the City of Conway, Arkansas. Said lands shall be classified for zoning purposes as agricultural.

SECTION 3: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance **be** passed and adopted; that an emergency exists; and that this ordinance shall take effect and be in force from and after its passage and publication.
