ORDINANCE NO. 09/-24

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS CITY OF CONWAY, ARKANSAS AND MAKING SAME A PART OF THE CITY OF CONWAY: DECLARING AN EMERGENCY: AND FOR OTHER PURPOSES

WHEREAS, a Petition was filed with the County Clerk of Faulkner County, Arkansas by the owner of the hereinafter described lands praying that said lands be annexed to and made a part of the city of Conway, Arkansas; and

WHEREAS, on the 9th day of April, 1991, the County Court of Faulkner County, Arkansas found that the Petition was signed by a majority of the total number of real property owners in said area proposed to be annexed and by the owners of more than one-half of the acreage of said area; that said lands are contiguous and adjoining the present corporate limits of the City of Conway, Arkansas; that an accurate map of said lands has been filed with and made a part of said Petition; that proper notice has been given for the time and in the manner prescribed by law; and that all things pertaining thereto had been done in the manner prescribed by law and that said lands should be annexed to and made a part of the City of Conway, Arkansas, subject to acceptance of same by the City Council of Conway.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS.

Section 1. The following described lands and all adjacent rights-of-way and easements contiguous to and adjoining the City of Conway, Arkansas be and same are hereby accepted as part of

and annexed to and made a part $\circ f$ the City of Conwap, Faulkner, Arkansas; to-wit:

of the NW $\frac{1}{4}$ The SW 1/4/of Section 16, Township 5 North, Range 14 West, containing 40 acres, more or less.

Section 2. That said lands are hereby declared to be a part of ward 2 of the City of Conway.

Section 3. That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
