AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY LAND DEVELOPMENT CODE; DECLARING AN EMERGENCY FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: That the zoning District Boundary Map of the Conway Land Development Code be amended by changing all the R-1 symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

Part of the $N_{\frac{1}{2}}^{\frac{1}{2}}$, Section 15, T-5-N, R-14-W, Faulkner County, Arkansas. Described as commencing at the NW Corner of said $N_{\frac{1}{2}}^{\frac{1}{2}}$, thence S-89 17' 12" E along the North line of said $N_{\frac{1}{2}}^{\frac{1}{2}}$ -NE $_{\frac{1}{4}}^{\frac{1}{4}}$, 615.0' to the point of beginning of herein described tract; thence continue S-89 17' 12" E along said North line, 358.83'; thence S-0 57'-W, parallel with the West line of said $N_{\frac{1}{2}}^{\frac{1}{2}}$ -NE $_{\frac{1}{4}}^{\frac{1}{4}}$, 1291.7' to the center line of a county road; thence S-83 35'-W along said center line, 361.79'; thence N-0 57'E, 1336.6' to the point of beginning.

to those of SR-Suburban Residential, and a corresponding use district is hereby established in the area above described and said property is hereby rezoned.

SECTION 2: That all ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 3: That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
