AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY LAND DEVELOPMENT CODE; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS"

SECTION 1: That the Zoning District Boundary Map of the Conway Land Development Code be amended by changing all the $\underline{\mathcal{K}} \cdot ($ symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

Part of the NW 1/4 SW 1/4 of Section 31, Township 6 North., Range 13 West, described as beginning at the southwest corner of the NW 1/4 SW 1/4, Section 31, T6N, R13W, and run thence south 88 degrees 12 minutes 30 seconds east 714.1 feet to the right-of-way of Interstate 40; thence along right-of-way north 42 degrees 06 minutes 30 seconds west 356.9 feet; thence along said right-of-way north 71 degrees 47 minutes 50 seconds west 467.2 feet; thence along said right-of-way north 7 degrees 07 minutes 52 seconds west 95.1 feet to the west line of the above said NW 1/4 SW 1/4; thence south 02 degrees 10 minutes west 483 feet to the point of beginning; containing 4.40 acres, more or less.
