SECTION 1: That the Zoning District Boundary Map of the Conway Land Development Code be amended by changing all the R-1 symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

TRACT 2: A part of the NW1/4 SE1/4, Section 36, Township 6 North, Range 14 West, more definitely described as follows: Beginning at a point 858 feet West and 230 feet South of the Northeast corner of said forty, which point is in the center of a public road, and running thence South 377.2 feet; thence East 226.5 feet; thence North 343.5 feet to center of said public road; thence Westwardly along said public road to point of beginning, containing 1 3/4 acres, more or less.
