

ORDINANCE NO. 0-98- 23

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: The City of Conway, Arkansas hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 21 day of January, 1998, and said territory being situated in Faulkner County, Arkansas shall be a part of the City of Conway and shall be zoned A-1 and described as follows:

The Northwest 1/4 of the Northwest 1/4 and the North 1/2 of the Northeast 1/4 of the Northwest 1/4 of Section 15, Township 5 North, Range 14 West.

and that said above-described land and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to ail the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original limits of said City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as part of Ward 1 of the City of Conway, Arkansas.

SECTION 3: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; and that this ordinance shall take effect and be in force from and after its passage and publication.

SECTION 1: The City of Conway, Arkansas hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 3rd day of February, 1998, and said territory being situated in Faulkner County, Arkansas shall be a part of the City of Conway and shall be zoned A-1 and described as follows:

The NW 1/4 NW 1/4 Section 30, T5N, R13W, containing 39.83 acres, more or less, in Faulkner County, Arkansas.

SW 1/4 NE 1/4

S 1/2 NW 1/4

N 2/3 N 1/2 SW 1/4

N 2/3 NW 1/4 SE 1/4

Part of NE 1/4 SE 1/4 West of old Highway 65, more particularly described as follows: beginning at the NW corner of said NE 1/4 SE 1/4 and from thence run South 20.00 chains; thence East 11.00 chains to the West boundary line of said highway; thence North 15 degrees West along the West boundary line of said highway 21.00 chains to the North line of the NE 1/4 SE 1/4; thence West 5.25 chains to the point of beginning; and containing 16.25 acres more or less

All in Section 30, T5N, R13W.

and that said above-described land and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original limits

of said City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as part of Ward 4 of the City of Conway, Arkansas.
