NOW, BE IT ORDAINED 13Y THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:


SECTION 1: The City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 16th day of __, 1998, said territory being situated in Faulkner County, December Arkansas, and described as follows:

Being a part of the SW1/4 NW1/4 and part of the NW1/4 NW1/4 Section 25, T5N, R14W, described as beginning at the SW corner of said NW 1/4 NW1/4; run thence N-0-22-18-W along the west line of said NW1/4 NW1/4 a. distance of 264 feet; thence N-89-38-44-E a distance of 270 feet; thence S-0-05-55-E a distance of 501.84 feet; thence N-85-20-28-W a distance of 271.63 feet to the west line of said SW1/4 NW1/4; thence N-0-25-34-E a distance of 214.12 feet to the point of beginning, containing 3.03 acres more or less. Reserving the south 25 feet for road easement.
