## AN ORDINANCE AMENDING THE CONWAY ZONING ORDINANCE TO EXEMPT SOME FACTORY BUILT BUILDINGS FROM HAVING TO OBTAIN A BUILDING MOVING PERMIT, DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

Whereas, a building moving permit is required for all buildings that are moved into or within the City of Conway, except for portable buildings as defined for the purposes of building moving permits, and

Whereas, a building moving permit is needed to insure that buildings are constructed in such a manner as to allow them to be moved in a safe manner and to insure: that there are no infestations of vermin that might be spread through the City by the movement of **the** buildings, and

Whereas, buildings that are built in factories and designed specifically for movement over public roads are generally assumed to be safe for movement on the roads and typically are not infested with vermin.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That <u>SECTION 1001.10 – EXEMPTIONS</u> of the Conway *Zoning* Ordinance as adopted by Ordinance 0-94-54 on September 27,1994 is hereby amended to add the following language:

"All buildings specifically designed **and** built to be transported over public roads are exempt from **the** requirements of **this** article. However, a building permit must be obtained prior to movement of the building and all building **codes** (including electrical, **mechanical** and all other relevant **codes**) must be met and the building must be inspected for compliance with those **codes** prior to final placement of the building on the parcel of lard. Furthermore, the permitting and **inspecting** department may require **a** report from a licensed **structural pest** control contractor stating the **condition** of the building or structure **as** to decay and pest infestation if it is deemed **necessary**. If the report is unsatisfactory, **the** building may be refused a building permit or any building permit that may have been issued may be voided."

Section 2: That any ordinances or parts of ordinances in effect **a**t the time of **the** passage of **this** ordinance that are in conflict with **this** ordinance are repealed **to the** extent of the conflict.

Section 3: That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance will be in full force and effect from and after its passage and approval.
