ORDINANCE NO. 0-02-08

AN ORDINANCE AMENDING ORDINANCE 0-76-32 TO EXTEND THE HOURS OF ONE-WAY TRAFFIC ON CERTAIN STREETS IN THE CITY OF CONWAY; DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

WHEREAS, because the hours of operation of the elementary schools in the City of Conway have been adjusted since Ordinance 0-76-32 was passed on Sept. 28, 1976; and

WHEREAS, earlier and slightly extended hours for one-way traffic will enhance the safety of the children attending the elementary schools;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

SECTION 1: Fourth Street is to be a one-way street going west from its intersection with Factory Street to its intersection with Harkrider Street from 7:30 a.m. to 9:00 a.m. and from 3:00 p.m. until 4:00 p.m. Monday through Friday during the ~~months~~ ^{time} that school is in session.

SECTION 2: South Boulevard is to be a one-way street going east from its intersection with Davis Street to its intersection with Center Street from 7:30 a.m. to 9:00 a.m. and from 3:00 p.m. until 4:00 p.m. Monday through Friday during the ~~months~~ ^{time} that school is in session.

SECTION 3: Poplar Street is to be a one-way street going east from 7:30 a.m. to 9:00 a.m. and from 3:00 p.m. until 4:00 p.m. Monday through Friday during the ~~months~~ ^{time} that school is in session.

SECTION 4: Lee Street is to be a one-way street going east from its intersection with Eastfield Street to its intersection with Donaghey Avenue from 7:30 a.m. to 9:00 a.m. and from 3:00 p.m. until 4:00 p.m. Monday through Friday during the ~~months~~ ^{time} that school is in session.

SECTION 5: All ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 6: This ordinance is necessary for the protection of the public peace, health and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
