AN ORDINANCE ACCEPTING THE ANNEXATION
LANDS TO THE CITY OF CONWAY, A RKANSAS; DECLARING
AN EMERGENCY; AND FOR OTHER PURPOSES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1: The City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 9th of September 2002 and said territory being situated in Faulkner County, Arkansas, shall be a part of the City of Conway and shall be zoned A-1 and described as follows:

Part of the SE1/4, Section 5,T-5-N, R-13-W, Faulkner County, Arkansas, described as beginning at the NW corner of said SE1/4 then run S88-33-27E, 1323.71 feet to the NW corner of the NE1/4 - SE1/4 of said Section 5; thence S88-22-43E, 1318.96 feet to the NE corner of said NE1/4 - SE1/4; thence SO-26-54W along the east line of said NE1/4 SE1/4, 739.40 feet to the NE comer of Lot 15 "T.H. Adcock" Subdivision; thence N88-13-43W, 261.0 feet to the NE comer of the West 135 feet of said Lot 15; thence S0-26-51W, 160.0 feet to the SE corner of the North 50 feet of the West 135 feet of Lot 14 "T.H. Adcock" Subdivision; thence N99-13-43W, 135.0 feet to the SW Comer of the North 50 feet of the West 135 feet of said Lot 14; thence SO-26-51W along the West line of the "T.H. Adcock" and the "Clara Rumpker" Subdivisions, 1337.61feet; thence N89-13-56W, 350.0 feet to the NW Comer of Lot 6 of said "T.H. Adcock" Subdivision; thence S0-26-51W, along the west line of said Lot 6, 326 18 feet to the north right of way of State Highway #64; thence N88-36W, along said right of way 119.50 feet hence N89-12-30W along said right of way, 386.53 feet to the east line of Lot 5 of said "T.H. Adcock" Subdivision; thence N0-30-23E, 943.55 feet to a found 5/8" rebar; thence N87-33-49W, 519.88 feet to a found 5/8" rebar; thence N0-28-45E, 1007.83 feet to a found 1" square iron pin; thence N89-21-09W, 867.05 to a found 11/2" iron pipe on the West line of said SE1/4; thence N0-01-46W, 625.36 feet to the point of beginning. Containing 86.741 acres more or less.


and that above said – described lands and **territory** be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

Section 2: That the City of Conway hereby accepts the following section(s) of street(s) as public street(s) for maintenance and for the purpose of providing street frontage for the issuance of building permits.

That portion of East German Lane that fronts upon this property.

Section 3: That unless a street is specifically named in this ordinance as being accepted for maintenance or to provide street frontage for the issuance of building permits, it shall not be accepted for either purpose.

Section 4: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations



imposed upon the inhabitants within the original limits of said City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as a part of **Ward** of the City of Conway, Arkansas.

Section 5: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance shall take effect and be in force immediately upon dedication of required right-of-way and passage and publication of this ordinance.
