ORDINANCE NO. 0-03- 119

**AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY ZONING ORDINANCE; TO REZONE PROPERTY WITH ITS WEST BOUNDARY 50 FEET FROM CATHERINE PLACE FROM O-1 TO R-1; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:**

**SECTION 1:** That the Zoning District Boundary Map of the Conway Land Development Code be amended by changing all the O-1 symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

Tract 2: A part of the NE1/4 SE1/4 of Section 14, T5N, R14W, Faulkner County, Arkansas, being more particularly described as beginning at the SW corner of said NE1/4 SE1/4; said point also being the NE corner of Catherine Place Subdivision; thence along the east line of said NE1/4 SE1/4 and Catherine Place Subdivision S-00-13-50-E, 39.06 feet to a point in the centerline of a creek, said point being the point of beginning; thence continue S00-13-50-E, 291.83 feet along said east line to a point on the north line of Lot 51, Oak Meadows Subdivision; thence along said north line N89-47-10-E, 380.49 feet to a point in the centerline of a creek; thence along said centerline N60-00-27-W, 20.16 feet; thence N69-49-04-W, 119.38 feet; thence N49-01-41-W, 154.25 feet; thence N43-21-04-W, 74.91 feet; thence N45-48-57-W, 107.89 feet; thence N39-38-00-W, 10.82 feet to the point of beginning. Said tract contains 1.05 acres, more or less.

to those of R-1, and a corresponding use district is hereby established in the area above described and said property is hereby rezoned.

**SECTION 2:** That all ordinances in conflict herewith are repealed to the extent of the conflict.

**SECTION 3:** That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
