### **ORDINANCE NO.** <u>0-05-173</u>

### AN ORDINANCE APPROPRIATING FUNDS FOR REPAIR COSTS FOR DAMAGES TO ASPHALT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

WHEREAS, the Council of the City of Conway has determined that it is appropriate to reimburse American Management Corporation ("AMC") for damage done to the asphalt parking lot by city owned vehicles, and approved payment of in the amount of \$2,350; and

WHEREAS, the above approved reimbursement was not previously budgeted and therefore requires budgetary appropriation.

### NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

**SECTION 1.** The City of Conway shall appropriate \$2,350 for reimbursement of repairs to AMC (01.115.237 Repairs & Services).

SECTION 2. All ordinances in conflict herewith are repealed to the extent of the conflict.

**SECTION 3.** This ordinance is necessary for the protection of the public peace, health, and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
