**ORDINANCE NO. O-06-19**

**AN ORDINANCE APPROPRIATING FUNDS FOR THE CONWAY FIRE DEPARTMENT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Conway Fire Department requests \$2,685 to purchase 4 uniforms and boots for new Honor Guard Members, depth limiters for 2 Stihl rescue saws, and an ice maker for Station 3.

**WHEREAS**, funds in the amount of \$2,250 were received by the Wal-Mart Foundation and \$443 from Fred's to be used for such purpose:

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:**


**SECTION 1.** The city of Conway shall appropriate \$2685 from the General Fund Revenue Donation Account to the Fire Department Uniform Expenses Operating Account (01.115.292, \$1036) and Fire Department Accountable Equipment Account (01.115.354, \$1,649).

**SECTION 2.** All ordinances in conflict herewith are repealed to the extent of the conflict.

**SECTION 3.** This ordinance is necessary for the protection of the public peace, health and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
