## City of Conway, Arkansas Ordinance No. O-13-11

AN ORDINANCE AUTHORIZING THE RECLASSIFICATION OF DISTRICT COURT CLERK AND AN ADIMINSTRATIVE ASSISTANT II POSITION IN DISTRICT COURT TO A DISTRICT COURT CLERK DIVISION II AND CHIEF DEPUTY COURT CLERK DIVISION I POSITION; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

WHEREAS, the District Court for the Ninth District would like to request the reclassification of the District Court Clerk and an Administrative Assistant II position to a Chief Deputy Court Clerk, Division I position and a District Court Clerk, Division II position.

WHEREAS, the annual salary for the District Court Clerk Division II position is \$53,483.00 and the annual salary for the Chief Deputy Court Clerk Division I position is \$53,483.00.

WHEREAS, the Chief Deputy Court Clerk Division I position shall perform those duties as directed by the District Judge, Division I, up to and including the duties of a district court clerk as set out by Arkansas Code Annotated § 16-17-211(c).

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

**SECTION 1.** The City of Conway shall reclassify the District Court Clerk and the Administrative Assistant II positions to a District Court Clerk Division II position and a Chief Deputy Court Clerk Division I position. The Chief Deputy Court Clerk Division I position shall perform those duties as directed by the District Judge, Division 1, up to and including the duties of a district court clerk as set out by Arkansas Code Annotated § 16-17-211(c).

**SECTION 2.** Additional salary funds are required for this staffing adjustment.

**SECTION 3.** All ordinances in conflict herewith are repealed to the extent of the conflict.

**SECTION 4.** That a copy of this ordinance shall be provided to the Faulkner County Quorum Court for its consideration pursuant to Ark. Code Ann. § 16-17-211(b) with respect to the position of District Court Clerk Division 2.

**SECTION 5.** This ordinance is necessary for the protection of the public peace, health and safety, including the effective and immediate administration of justice in the Ninth District; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
