AN ORDINANCE APPROPRIATING 2020 REIMBURSEMENTS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES

Whereas, the City of Conway has received reimbursements funds from the following entities:

Various Companies	\$70,379.84	Extra Duty Services
Municipal Vehicle Program	\$2,949.88	Insurance Proceeds
AR State Police	\$4,030.04	Taskforce Funds
DEA/Marshall	\$3,545.95	Taskforce Funds

Whereas, the Conway Police Department needs these funds to replenish their expenditure accounts.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate funds from various companies in the amount of \$70,379.84 from 001.121.4185 to the CPD overtime account, 001.121.5114.

Section 2. The City of Conway shall appropriate funds from Municipal Vehicle Program in the amount of \$2949.88 from 001.119.4360 to the Police Department vehicle maintenance expense account 001.121.5450.


Section 3. The City of Conway shall appropriate funds from Arkansas State Police in the amount of \$4,030.04 from 304.000.4201 to the Police Department overtime expense account 001.121.5114.

Section 4. The City of Conway shall appropriate funds from federal funds in the amount of \$3,545.95 from 001.121.4186 to the CPD overtime account 001.121.5114.


Section 5. All ordinances in conflict herewith are repealed to the extent of the conflict.

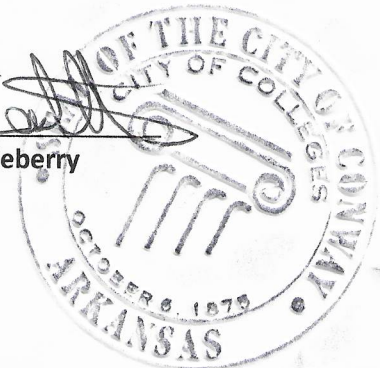
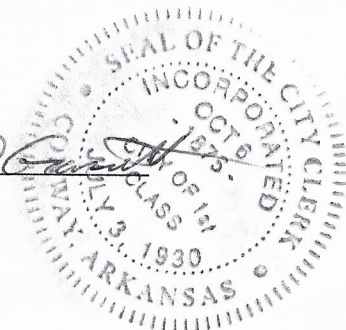
