


RESOLUTION NO. R-84-43

We are not trying to set a precedent by asking for this donation, we just need your help this year and hope that you will be able to see how important the Christmas Parade is to many people in our community.

Organizations (Civic Clubs) Involved - 10  
Number of Bands - 6

Although the above is our main concern, the tax money generated by the attendants of the Christmas Parade should actually be enough to pay for the parade several times over.


The money, if received, will be used for prize money and honorarium for the floats and bands.
