

RESOLUTION

BE IT RESOLVED, by the City Council of the City of Conway, Arkansas, that WHEREAS, the Council of the City of Conway, Arkansas, has been informed that Antioch Baptist Church, have petitioned or will petition the County Court of Faulkner County, Arkansas, for annexation into the City of Conway, Arkansas, of the following described lands in Faulkner County, Arkansas:

Part of the SE 1/4 SE 1/4, Section 4, Township 5 North, Range 14 West, described as follows: Beginning at the southeast corner of said SE 1/4 SE 1/4, and run north along and with the east line of said SE 1/4 SE 1/4, a distance of 43.95 feet to the north line of the right-of-way of State Highway 60 and the point of beginning of the lands being described; thence westwardly, along and with the said north right-of-way line a distance of 533.54 feet; thence north 20 degrees 13 minutes west 329.52 feet; thence north 30 degrees 25 minutes west 222.64 feet; thence north 14 degrees 21 minutes west 228.10 feet; thence north 88 degrees 55 minutes east 278.50 feet; thence south 01 degrees 05 minutes east 25 feet; thence north 55 degrees 42 minutes east 692.37 feet to the east line of said Section 4; thence south 01 degrees 56 minutes west, along and with said east line, a distance of 1,068.78 feet to the point of beginning, containing 13.46 acres more or less.

Furthermore, the petitioner requests that all lands hereinabove described be given a **A1 zoning class**.


Said lands are contiguous to and adjoin lands which are included within the corporate limits of the City of Conway, Arkansas.
