On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Hawkins, Alderman Grimes, Alderman Jones, Alderman Pruitt, Alderman Ledbetter, Alderwoman Whitmore, & Alderwoman Smith. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael O. Garrett & City Attorney Michael Murphy. **Alderwoman Mehl was not present.**

Ordinances Passed:

- O-14-43 Ordinance to rezone property located at the northeast corner of Deerbrook Drive and Old Military Road from A-1 to R-1. **Vote 7-0**
- O-14-44 Ordinance appropriating grant funds in the amount of \$15,000 from the AR State Highway Safety Program to the District Court. **Vote 7-0**
- O-14-46 Ordinance amending the City of Conway Sign Ordinance lowering the cap on billboards to 32. **Vote 6-1 w/ Alderman Ledbetter voting against.**
- O-14-47 Ordinance repealing Ordinance No. O-76-09 & Ordinance No. O-87-04. **Vote 7-0**

Ordinance Failed:

- O-14-45 Ordinance amending the City of Conway Sign Ordinance prohibiting billboards. **Failed 3-4 w/ Alderman Jones, Ledbetter & Alderwoman Smith and Whitmore voting against it.**

Resolution Passed:

- R-14-12 Resolution allowing Snap-On Equipment participation in the tax back program. **Vote 7-0**
- R-14-13 Resolution authorizing the Mayor to sign an amendment to the operating agreement among the co-owners of the White Bluff Steam Electric Station for Conway Corporation. **Vote 7-0**
- R-14-14 Resolution authorizing the Mayor to accept a grant from the Federal Aviation Administration for up to \$2,261,568. **Vote 7-0**

In Other Actions:

- Approved May 13th, 2014 City Council Minutes. **Vote 7-0**
- Approved Conditional use permit for Maurice McClure to allow an auto body shop for property that is located at 2955 Dave Ward Drive. **Vote 7-0**
- Approved Monthly Financial Report ending April 30th, 2014. **Vote 7-0**
