City of Conway -- City Council Brief
October 10th, 2006

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-06-134-A} establishing the traditional neighborhood development overlay district. **Vote 7-0**
- Ordinance {O-06-135} authorizing the acceptance of bids for asphalt overlay and resurfacing of tennis courts from Professional Court Resurfacing at \$44,800 for Laurel Park and \$23,800 for Gatling Park and appropriate of funds in the amount of \$68,600. **Vote 7-0**
- Ordinance {O-06-136} appropriating funds in the amount of \$6,000 to be used to build three (3) backstops and to run underground power lines to pitching mounds to provide power to pitching machines. **Vote 7-0**
- Ordinance {O-06-137} appropriating funds in the amount of \$5,300 to replenish the grounds maintenance account. **Vote 7-0**
- Ordinance {O-06-138} appropriating funds in the amount of \$6,000 for expenses related to District Court automation and for other expenses. **Vote 7-0**
- Ordinance {O-06-139} creating an Old Conway Design Overlay District. **Vote 7-0**

Resolutions Passed

- Resolution {R-06-33} supporting the proposed Higher Education Bond Initiative being voted on in the November 7, 2006 General Election. **Vote 7-0**
- Resolution {R-06-35} of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for paid non-uniformed employees. **Vote 7-0**
- Resolution {R-06-36} of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue the exclusive purpose of operating and maintaining the cemeteries for the City of Conway. **Vote 7-0**

- Resolution {R-06-37} of a levy of one and nine-tenth's (1.9) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising General Fund Revenues. **Vote 7-0**
- Resolution {R-06-38} of a voluntary levy of two-tenth's (.2) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for a Animal Shelter for the City of Conway. **Vote 7-0**
- Resolution {R-06-39} of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a Policeman's Pension and Relief Fund. **Vote 7-0**
- Resolution {R-06-40} of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a Fireman's Pension and Relief Fund. **Vote 7-0**
- Resolution {R-06-41} of a voluntary levy of four-tenth's (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for a recreation assessment raising special revenue for the sole and exclusive purpose of providing additional funds for the purpose of construction, equipping, operating and maintaining the public recreation and playgrounds of City of Conway. **Vote 7-0**

- ♦ Approved the bid purchase of a 2yd compactor w/ 40yd receiver for CHA in the amount of \$20,230.17 from low bidder Downing Sales. **Vote 7-0**
- ♦ Approved the conditional use permit for a transmission tower/station (cell tower) for property located in the North Plaza Shopping Center (2125 Harkrider St) **Vote 6-1 w/ Alderman Weeks voting against.**
- ♦ Approved a parking lot variance for Hank's Furniture located at 650 Museum Road. **Vote 7-0**
- ♦ Approved moving the December 26 city council date to December 28th, 2006. **Vote 7-0**
- ♦ Approved the selection of Kutak Rock as bond counsel and Stephens Inc. for underwriter for City of Conway. **Vote 5-0 w/ Alderman Bell & Weeks abstaining.**
