At its meeting the Conway City Council took the following actions:

Ordinances Passed.

- Ordinance {O-06-149} authorizing the issuance and sale of not to exceed 5,200,000 franchise fee revenue improvement bonds, series 2006 for the City. **Vote 8-0**
- Ordinance {O-06-150} an amendment to allow property less than 3 acres to be zoned PUD; replacing the 20% common space requirement, allow shared parking and procedural corrections. **Vote 8-0.**
- Ordinance {O-06-151} appropriating funds in the amount of \$464,110 for a 2 ram baler & conveyor for the City Sanitation Department. **Vote 8-0**
- Ordinance {O-06-152} appropriating funds in the amount of \$36,597 for 96 Gallon Universal Refuse Carts & Universal Refuse Roll Carts for the City Sanitation Department. **Vote 8-0**
- Ordinance {O-06-153} appropriating insurance proceeds in the amount of \$17,042 and transferring additional funds in the amount of \$1,585 for vehicle replacement purchase for the Conway Sanitation Department. **Vote 8-0**
- Ordinance {O-06-154} appropriating donated funds in the amount of \$100 from the National Recreation and Parks Association to the Parks Department **Vote 8-0**
- Ordinance {O-06-155} approving the purchase of two new vehicles from State Contract and appropriation of funds in the amount of \$40,959 for the Parks Department. **Vote 8-0**
- Ordinance {O-06-156} amending section 1 of Ordinance No. O-05-170 due to a typographical error. **Vote 6-2 w/ Alderman Brewer & Weeks voting against.**
- Ordinance {O-06-157} amending section 1 of Ordinance No. O-05-88 due to a typographical error. **Vote 6-2 w/ Alderman Brewer & Weeks voting against.**
- Ordinance {O-06-158} appropriating animal welfare voluntary tax revenues in the amount of \$4,300 to AWU for special purchases. **Vote 8-0**
- Ordinance {O-06-159} waiving bids for telephone and network wiring for the City and awarding Service Plus the contract for the remainder of the year. **Vote 8-0**
- Ordinance {O-06-160} appropriating funds in the amount of \$124,500 for employee appreciation bonus in the amount of \$250 for full time employees & \$125 for part time employees. **Vote 8-0**
