At its meeting the Conway City Council took the following actions:

**Ordinances Passed:**

- Ordinance {O-07-34} closing a utility easement located at the south fifteen feet of Lot 1A-1 of the replat Lot 1A in Scherman Heights. **Vote 8-0.**
- Ordinance {O-07-35} closing a portion of West Simms Street (unimproved between Hubbard and Denison Street). **Vote 8-0**
- Ordinance {O-07-36} appropriating funding in the amount of \$26,338 for the Faulkner County Senior Citizens Program for transportation services. **Vote 8-0**
- Ordinance {O-07-37} appropriating funding in the amount of \$12,500 for the Faulkner County Council of Developmental Disabilities for transportation services. **Vote 8-0**
- Ordinance {O-07-38} accepting the annexation of certain lands located south of Cresthaven Subdivision Phase II west of Mill Pond Road. **Vote 8-0**
