At its meeting the Conway City Council took the following actions:

**Ordinances Passed:**

- Ordinance {O-07-55} granting a temporary franchise agreement to Robert Haskett, owner of the Brewery, to operate a vending cart in Simon Park. **Vote 6-0 w/ Alderman Bell & Hawkins not present.**
- Ordinance {O-07-56} appropriating asset forfeiture funds in the amount of \$3,000 for the CPD to purchase a CVSA laptop. **Vote 6-0**
- Ordinance {O-07-57} waiving bids for allocation of court automation funds in the amount of \$10,000 for District Court to cover cost of computer repair and maintenance. **Vote 6-0**
- Ordinance {O-07-58} appropriating funds in the amount of \$32,432.60 for the addition of a Special Projects Manager position to the existing pay grid. **Vote 5-1 for the ordinance with Alderman Vaught voting against and 6-0 for the emergency clause.**
- Ordinance {O-07-59} appropriating funds in the amount of \$9321 for an ATV Mule Truck, water tank, pump and hoses for the Physical Plant. **Vote 6-0**
