City of Conway -- City Council Brief
October 9th, 2007

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-07-124} accepting donations and appropriating funds in the amount of \$11,968 for the Orchard Park road improvements. **Vote 8-0**
- Ordinance {O-07-125} to rezone property located on the North side of Highway 64 East Oak Street from A-1 to C-3. **Vote 8-0**
- Ordinance {O-07-127} to rezone property located approximately 300 feet north-northeast of the Donaghey Avenue/Meadowlake Road intersection, directly in front of the original phase of June Beene apartments (the westernmost apartments) from O-2 to O-1. **Vote 8-0**
- Ordinance {O-07-128} waiving bids for the purchase of a transmission for the Terex dirt truck for the Sanitation Dept. **Vote 8-0**
- Ordinance {O-07-129} appropriating funds not to exceed 26,364.06 for office equipment for City Hall and CPD – Records. **Vote 8-0**
- Ordinance {O-07-130} amending the fees collected by the Conway Permit Department. **Vote 8-0**

Ordinances Failed: None

- Ordinance {O-07-126} to rezone property located at the northwest corner of Prince Street at Country Club Road intersection and extending north along Country Club Road for approximately one-quarter of a mile from A-1 to R-1. **Vote 7-1 w/ Alderman Vaught voting for the rezoning.**

Resolutions Passed: None

- Resolution {R-07-29} approving a contract of obligation with the Department of Environmental Quality. **Vote 8-0**

Resolutions Failed: None

Other Actions:

In other actions, the Council:

- ♦ Approved minutes from the September 25th, 2007 City Council meeting. *Vote 8-0*
- ♦ Approved entering into the agreement with Peters & Associates for traffic signal coordination on Oak St., Prince St., & Donaghey Ave. *Vote 8-0*
- ♦ Approved the bid from Downing Sales in the amount of \$122,533.00 for the purchase of a Commercial Rear Load Refuse truck for the Sanitation Department. *Vote 8-0*
- ♦ Approved the low bid from Business World in the amount of \$22,724 for two digital copiers, one for City Hall & one for the CPD. *Vote 7-1 w/ Alderman Smith voting against.*

Held in Committee/No action taken:

- Ordinance to remove the 7.5 floodway easement on Lots 28 & 45 in the Weatherstone Subdivision. *Vote 8-0*
