At its meeting the Conway City Council took the following actions:

**Ordinances Passed:**

- Ordinance {O-08-40A} closing the 15 foot utility easement between 1A & 2A and the 7.5 foot utility easement on the east side of Lot 1A & 2A of Runway Park of the Runway Park Subdivision Lot 1 Replat. **Vote 8-0**
- Ordinance {O-08-41} appropriating funds in the amount of \$3,470 for Civil Service expenses related to fire and police testing. **Vote 8-0**
- Ordinance {O-08-42} waiving bids & utilizing Med Eng for the purchase of two EOD 9A bomb helmets for the CFD. **Vote 8-0**
- Ordinance {O-08-43} accepting donated ballistic shield with a stated value of \$2,000 from the United States Postal Inspection Service to the Conway Police Department. **Vote 8-0**
