**At its meeting the Conway City Council took the following actions:**

**Ordinances Passed:**

- Ordinance {O-08-104} appropriating funds in the amount of \$61,763 for parking deck design consultation from Wilcox Group. **Vote 6-0**
- Ordinance {O-08-105} amending the Conway Subdivision ordinance to require curbs to be four inches roll curbs. **Vote 6-0**
- Ordinance {O-08-106} accepting an asset forfeiture item (Kimbrow Pro Carry .45 Caliber Gun) from the District Court of Faulkner County to the City of Conway. **Vote 6-0**
- Ordinance {O-08-107} appropriating funds to purchase UPS batteries in the amount of \$5,994 for the Communication Center. **Vote 6-0**
- Ordinance {O-08-108} appropriating funds in the amount of \$ 23,000 to the Conway Police Department to replenish line items vehicle maintenance & tires. **Vote 6-0**
- Ordinance {O-08-109} to accept insurance proceeds in the amount of \$4,275 from State Farm for the Conway Fire Department. **Vote 6-0**

- Approved the minutes from August 26<sup>th</sup>, 2008 City Council Meeting. **Vote 6-0.**
- Approved the nomination of Eric King by Ald. Vaught to the Parks Advisory Committee. **Vote 6-0**

- Approved w/ conditions a conditional use permit for an adult day care providing professional services to the mentally ill for property located at 132 Lower Ridge Road. **Vote 5-1-1 w/ Mayor Tab Townsell voting with majority, Alderman Vaught voting against and Alderman Whitmore abstaining.**
- Approved the low bid from N.E.O. Fab in the amount of \$4,402 for 30 yard roll off containers for the Sanitation Department. **Vote 6-0**
- Approved to allow the Conway Police Pension Board to request an increase in benefits from the Arkansas Pension Review Board. **Vote 6-0**
- Approved 2009 Medical (Blue Cross Advantage – 3% increase); Dental (Blue Cross – 2%), & Life (United Health Care – Zero premium increase). **Vote 6-0**
- Approved 2009 Voluntary Benefits provided by Benefit Partners/Flexco Inc. **Vote 6-0**
- Approved to fund up to \$2500 in repairs for damages done by flooding to the City/Clerk Treasurer's Office. **Vote 6-0**
- Approved for Faulkner County to sell the trees/timber from the fairground property to offset cost related to gas/diesel and other related expenses. **Vote 6-0**

**Held in Committee/No Action Taken/Withdrawn**

- Ordinance to grant Conway Corporation a franchise agreement to operate cable television system within the City of Conway.
- Ordinance to provide for the lease services of the City cable television system to Conway Corporation.
- Ordinance entering into a franchise agreement with AT&T for video services within the City of Conway.
- Consideration of a sign variance for property located at 1014 Harkrider Street (Sav-on Pharmacy)
- Consideration of allowing Campus Crest a rezoning rehearing to go back before the Planning Commission for development located at 2730 Dave Ward Drive.
