At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-09-76} authorizing the issuance and sale of wastewater revenue improvement bonds, Series 2009. **Vote 7-0 w/ Alderman Jones not present.**
- Ordinance {O-09-77} appropriating funds in the amount of \$2,600 for an Art Display System & lighting for Conway City Hall. **Vote 7-0**
- Ordinance {O-09-78} amending Title 8 of the Municipal Code in regards to two hour parking. **Vote 7-0**
- Ordinance {O-09-79} rezoning property located at 1502 Boen Street from MF-3 to RU-1. **Vote 7-0**
- Ordinance {O-09-80} authorizing the Physical Plant to enter into a lease agreement with Ag Pro & appropriate funding in the amount not to exceed \$5,000 a year to lease a John Deere Tractor for a period of 5 years; also appropriate funds in the amount not to exceed \$2,000 for a trailer. **Vote 6-0 w/ Alderman Hawkins abstaining from the vote.**
- Ordinance {O-09-81} appropriating funds in the amount of \$8,500 for civil service expenses related to police officer testing. **Vote 7-0**
- Ordinance {O-09-82} amending Title 6 of the Conway Municipal Code in regards to animal welfare changes. **Vote 7-0**
- Ordinance {O-09-83} authorizing the Conway Fire Department to apply for the SAFER Grant. **Vote 7-0**
