The following members being a quorum, were present and acting: Alderman Hawkins, Alderwoman Smith, Alderman Grimes, Alderwoman Mehl, Alderman Vaught, Alderman Jones, Alderman Rhodes & Alderwoman Whitmore. ***At its meeting the Conway City Council took the following actions:***

**Ordinances Passed:**

- Ordinance {O-10-40} accepting a donation of a grill (valued at \$200) to the Conway Police Department (Communication Center). **Vote 8-0**
- Ordinance {O-10-41} accepting restitution & appropriating funds in the amount of \$51,921.25 for overtime performed by the Conway Police Department. **Vote 8-0**

**Resolutions Passed:**

- Resolution {R-10-13} expressing the intent of the City to accept the Transit Feasibility Study prepared by Metroplan. **Vote 8-0**
- Resolution {R-10-14} authorizing the Mayor to enter into an amended agreement with the AR State Highway Department for the construction of a new Interchange on Interstate 40 at the Southern terminus of the Conway Western Arterial Loop. **Vote 8-0**
