On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum, were present and acting: Alderman Hawkins, Alderman Grimes, Alderwoman Smith, Alderwoman Mehl, Alderman Vaught, Alderman Rhodes, Alderman Jones, & Alderwoman Whitmore. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, and City Attorney Michael Murphy.

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-10-80} to accept grant proceeds in the amount of \$5400 and to appropriate funds for the Historic District Commission to be administered by the Planning Department. **Vote 8-0**
- Ordinance {O-10-81} accepting a donation from Conway Cobras in the amount of \$218 for scholarships in the youth baseball program at the Conway Parks Department. **Vote 8-0**
- Ordinance {O-10-82} appropriating funds in the amount of \$3,502 for the Conway Parks Department per the Compromise, Settlement and Release Agreement between Carter & Burgess, Inc., Nabholz Construction Corporation and the City of Conway. **Vote 8-0**
- Ordinance {O-10-83} to repeal Ordinance O-10-65 that regulated the possession, sale and ingestion of K-2 within the City of Conway. **Vote 6-1-1 w/ Alderman Vaught voting against and Alderman Hawkins voting present.**

- Resolution {R-10-37} authorizing the Mayor & City Clerk to enter into the termination and assignment agreement with co-owners of the Independence Steam Electric Station 2. **Vote 8-0**
- Resolution {R-10-38} setting a public hearing on August 10, 2010 to discuss closing an easement located on Lot 1 in University Park Subdivision. **Vote 8-0**
- Resolution {R-10-39} requesting the Faulkner County Tax Collector to place a certified lien on property located at 4910 College Avenue as a result of incurred expenses by the City. **Vote 8-0**

- Resolution {R-10-40} requesting the Faulkner County Tax Collector to place a certified lien on property located at 1515 Freyaldenhoven Lane as a result of incurred expenses by the City. **Vote 8-0**
- Resolution {R-10-41} requesting the Faulkner County Tax Collector to place a certified lien on property located at 2 Eve Lane as a result of incurred expenses by the City. **Vote 8-0**
