***At its meeting the Conway City Council took the following actions:***

**Ordinances Passed:**

- Ordinance {O-10-126} to rezone property located at 855 Salem Road & 2945 Prince Street (Kroger Rezoning) from O-3 and C-2 to PUD (Planned United Development). **Vote 5-3 w/ Alderman Rhodes, Grimes & Alderwoman Smith voting against.**
- Ordinance {O-10-127} appropriating insurance funds in the amount of \$3826 to the Conway Animal Shelter. **Vote 8-0**
- Ordinance {O-10-128} appropriating & accepting grant funds and insurance funds from various entities for the Conway Police Department. **Vote 8-0**

**Ordinances Failed: None**

**Resolutions Passed:**

- Resolution {R-10-74} requesting the Faulkner County Tax Collector to place certified liens on property located at 1515 Freyaldenhoven Lane as a result of incurred expenses by the City. **Vote 8-0**
