On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderwoman Mehl, Alderman Hawkins, Alderman Grimes, Alderman Vaught, Alderman Rhodes, Alderwoman Whitmore & Alderman Jones. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, & City Attorney Michael Murphy. **Alderwoman Smith was not present.**

### Ordinance Passed:

- O-11-95 Ordinance appropriating funds in the amount of \$200,000 from Conway Corporation for the New Conway Municipal Airport. **Vote 7-0**
- O-11-96 Ordinance accepting & appropriating donated funds in the amount of \$758 for the Conway Fire Department **Vote 7-0**

### Resolution Passed:

- R-11-67 Resolution requesting the Faulkner County Tax Collector to place a certified lien on 3035 Franklin Circle as a result of incurred expenses by the City. **Vote 7-0**
- R-11-68 Resolution requesting the Faulkner County Tax Collector to place a certified lien on 3910 Rupert Drive as a result of incurred expenses by the City. **Vote 7-0**

### In Other Actions:

- Approved the minutes from the November 1<sup>st</sup>, 2011 City Council meeting. **Vote 7-0**
- Approved to accept the following bids for the Conway Street Department:
  - JA Riggs CAT 303.5C Mini Track Mounted Hydraulic Excavator (used) \$26,800
  - JA Riggs CAT D3K Crawler Dozer (used) \$49,800
  - Hugg & Hall Volvo Ec160CL Track Mounted Hydraulic Excavator \$110,783
  - All bids were rejected for the Tractor w/ 5<sup>th</sup> Wheel – **Vote 7-0**
- Approved the following vendors for the 2012 Medical, Dental, and Life Plans for the City of Conway:
  - Health Advantage High and Low Option Medical Plans
  - Blue Cross/Blue Shield High and Low Option Dental Plans
  - USABLE Life Insurance **Vote 7-0**
