Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, & City Attorney Michael Murphy.*

- O-12-62 Ordinance establishing and amending rules and regulations for parks and park facilities in the City of Conway. **(As amended) Vote 8-0**
- O-12-63 Ordinance accepting & appropriating funds in the amount of \$4,800 for the planting of trees along Dave Ward Drive. **Vote 8-0**
- O-12-64 Ordinance accepting grant proceeds and appropriating funds in the amount of \$1600 for Conway EcoFest 2012. **Vote 8-0**
- O-12-65 Ordinance to rezone property located at 1605 East Oak Street from R-1 & C-3 to PUD. **Vote 8-0**
