On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderwoman Mehl, Alderman Ledbetter, Alderman Pruitt, Alderman Jones, Alderwoman Whitmore, Alderwoman Smith, & Alderman Jones. Also, present and acting: Mayor Tab Townsell & City Attorney Michael Murphy. **Alderman Grimes & Clerk/Treasurer Michael O. Garrett were not present.**

**Ordinances Passed:**

- O-13-111 Ordinance appropriating funds in the amount of \$50,000 to match the Markham Street Project Jump Start Grant received by Metroplan in the amount of \$180,000 **Vote 7-0 w/ Alderman Grimes not present**
- O-13-112 Ordinance appropriating funds in the amount of \$3,100 to reflect a new market rate established by the 2013 JESAP Salary Study for the City Engineer/Street Director. **Vote 7-0**
- O-13-113 Ordinance authorizing the reclassification of a part time collector to a full time collector for the Sanitation Department. **Vote 7-0**
- O-13-114 Ordinance authorizing a change in staffing levels for the Parks & Recreation Department. **Vote 7-0**

- R-13-63 Resolution requesting the Faulkner County Tax Collector to place a lien in the amount of **\$205.71** on property located at **1 Wingate Drive** for incurred expenses by the City.

- R-12-66 Resolution of a voluntary levy of two-tenth's (.2) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for a **Animal Shelter** for the City of Conway. **Vote 7-0**
- R-12-67 Resolution of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a **Policeman's Pension and Relief Fund**. **Vote 7-0**
- R-12-68 Resolution of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a **Fireman's Pension and Relief Fund**. **Vote 7-0**
- R-12-69 Resolution of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for paid **Non-uniformed employees**. **Vote 7-0**

- R-12-70 Resolution of a levy of four-tenths (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue the exclusive purpose of operating and maintaining the **cemeteries** for the City of Conway. **Vote 7-0**
- R-12-71 Resolution of a voluntary levy of four-tenth's (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for a recreation assessment raising special revenue for the sole and exclusive purpose of providing additional funds for the purpose of construction, equipping, operating and maintaining the **public recreation and playgrounds** of City of Conway. **Vote 7-0**
- R-12-72 Resolution of a levy of one and nine-tenth's (1.9) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising **General Fund Revenues**. **Vote 7-0**

- Approved Bid received from Dayco Construction in the amount of \$473,400 for (3) comfort stations for separate parks Gatlin park, Laurel Park, & Beaverfork Park in the Parks and Recreation Department. **Vote 7-0**

- Reviewed Conditional use permit for BackAchers Ranch, for which they were given two weeks to work with the City's Planning Department regarding landscape requirement at the property. **Vote 7-0**
