**Ordinances Passed:**

- O-17-15 Ordinance to close a portion of a utility/drainage easement located on Lot 17 Princeton Village PUD. **Vote 8-0**
- O-17-16 Ordinance authorizing the reclassification one construction specialist position and one stormwater technician position to two job supervisor in the Street & Engineering Department. **Vote 8-0**
- O-17-17 Ordinance authorizing the reclassification of the Deputy Mayor position in Administration Department to a Purchasing Manager and a Budget Analyst II position in Finance to a Grant Administrator in the Adm. Dept. **Vote 7-0-1 w/ Alderman Hawkins voting here.**

- R-17-04 Resolution setting a public hearing on February 28<sup>th</sup>, 2017 to discuss the closing of a utility easement located on Lot 2, Acxiom commercial addition. **Vote 8-0**
