On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Hawkins, Alderman Grimes, Alderwoman Mehl, Alderman Pruitt, Alderwoman Smith, Alderman Ledbetter, & Alderwoman Isby. Also, present and acting: Mayor Bart Castleberry, City Clerk/Treasurer Michael O. Garrett, & City Attorney Chuck Clawson. **Alderman Jones was not present.**

Ordinances Passed:

- O-19-01 Ordinance approving the private club permit for Foghorn's located at 2310 Sanders Road. **Vote 7-0**
- O-19-02 Ordinance clarifying the fees for the construction and alterations of buildings and building systems & temporary certificate of occupancy. **Vote 7-0**
- O-19-03 Ordinance accepting and appropriating proceeds in the amount of \$14,000 from Faulkner County for GIS work per the interlocal agreement for use by the Planning & Development Department. **Vote 7-0**
- O-19-04 Ordinance to rezone property located at 1630 Bill Lucy Drive from R-1 to PUD. **Vote 7-0**
- O-19-05 Ordinance waiving competitive bids and accepting grant proceeds in the amount of \$186,498 awarded to the Conway Fire Department Bomb Squad. **Vote 7-0**
