Ordinances Passed:

- O-17-63 Ordinance appropriating grant funds in the amount of \$1,576.02 for the Spencer Street Brownfield Cleanup Project. **Vote 6-0**
- O-17-64 Ordinance appropriating match funds in the amount of \$40,000 and extending its expiration period for an EPA Brownfield Cleanup Grant for 1110 Spencer Street (former Scrap Metal yard property). **Vote 6-0**
- O-17-65 Ordinance accepting and appropriating donation funds in the amount of \$7,481.51 for the Conway Historic District Commission for Commissioner training. **Vote 6-0**
