On this date the City Council of the City of Conway, Arkansas met in regular session via Zoom. The following members being a quorum were present and acting; Alderman Hawkins, Alderman Pruitt, Alderwoman Mehl, Alderwoman Smith, Alderman Ledbetter, & Alderwoman Isby. Also, present and acting: Mayor Bart Castleberry, City Attorney Charles Finkenbinder, & City Clerk/Treasurer Michael O. Garrett. **Alderman Grimes and Alderman Jones were not present.**

## **Ordinance Passed**

- O-21-32 Ordinance approving the private club permit for Los Gallitos Mexican Restaurant of Conway, Inc. to be located at 1250 Old Morrilton Highway Conway, AR 72032. **Vote 6-0**
- O-21-33 Ordinance to enter into an agreement with Rock Region Metro to provide microtransit services. **Vote 6-0**
- O-21-34 Ordinance establishing penalties for code violations for the Permits & Inspections Department. **Vote 6-0**
- O-21-35 Ordinance rezoning property located at 2310 E Oak St. from C-3 and R-1 to S-1 for the Planning Department. **Vote 6-0**
- O-21-36 Ordinance authorizing personnel changes to add a Safety and Training Manager for the Administration Department. **Vote 6-0**
- O-21-37 Ordinance appropriating funds for the purchase of certain capital items for various departments:
- o \$50,000 – CFD (Cardiac monitor and a firefighting mask testing machine).
  - o \$10,000 – Physical Plant (Mower)
  - o \$21,000 – Information Technology (Vehicle). **Vote 6-0**
- O-21-38 Ordinance approving a partnership with Conway Public Schools and appropriating funds in the amount of \$23,250 for a school bus camera system. **Vote 6-0**
