Vote 7-0 R-20-91 Resolution of a levy of four-tenth's (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a *Fireman's* **Pension and Relief Fund**. Vote 7-0 R-20-92 Resolution of a levy of four-tenth's (.4) mill on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for paid Nonuniformed employees.
