- O-21-100 Ordinance accepting and appropriating grant funds, in the amount of \$23,000, from the Federal Aviation Administration for the Conway Regional Airport. **Vote 8-0**
- O-21-101 Ordinance appropriating funds, in the amount of \$48,054.99, from Govdeals.com for the Transportation Department. **Vote 8-0**
- O-21-102 Ordinance authorizing the addition of a Heavy Equipment Mechanic I position for the Transportation Department. **Vote 8-0**
- O-21-103 Ordinance rezoning property located at 517 Fifth Street from R-2A to R-2. **Vote 6-2 with Alderman Grimes and Alderman Hawkins voting against.**
- O-21-104 Ordinance to rezone +/- 55.16 acres located at E Dave Ward Drive and Thomas G Wilson Drive from A-1 and C-3 to PUD. **Vote 6-2 with Alderman Grimes and Alderman Pruitt voting against.**
