A trip hazard’s actual measurement at the time of repair exceeds approved customer specifications, and/or 2. In the crew leader’s judgment, our repair attempt would cause further damage to the concrete panel or be insufficient to satisfactorily remove the existing hazard and/or mitigate its potential liability. Such excluded trip hazards, if any, will be left “as found” and will require customer’s alternative remedy. All “Excluded Repairs” included on the original survey will be fully credited to the customer on the final invoice.

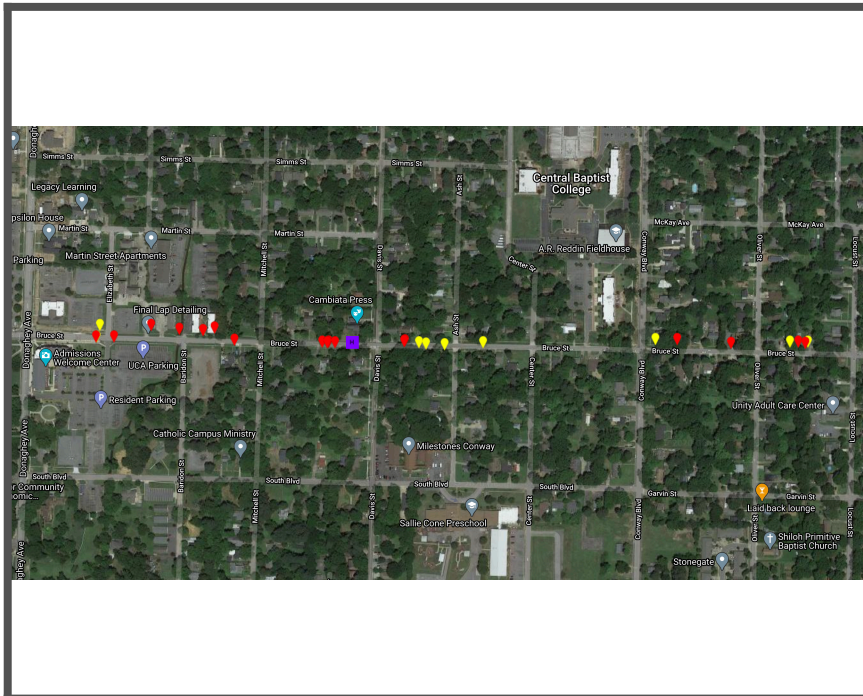
