On this date, the City Council of the City of Conway, Arkansas, met in regular session. The following members, being a quorum, were present and acting: *Councilman Hawkins, Councilman Grimes, Councilman Hawks, Councilman Ledbetter, Councilman Jones and Councilwoman Isby*. Also, present and acting: *Mayor Bart Castleberry, City Attorney Charles Finkenbinder, & City Clerk/Treasurer Denise Hurd. Councilman Spurgers, and Councilwoman Mehl were not present.*

Resolutions Passed:

- R-26-21** Resolution expressing the willingness of the City of Conway, in partnership with Conway Corporation, to apply for Congressionally Directed Spending for the Tucker Creek Equalization Storage Facility Project. **Vote 6-0**
- R-26-22** Resolution approving an agreement for general legal services the Owen & Parker Law Firm to provide on-call legal services for the Advertising and Promotion Commission. **Vote 6-0**
- R-26-23** Resolution approving the Conway Emergency Utility Assistance program beginning in early 2027 for the Community Development Department. **Vote 6-0**
- R-26-24** Resolution approving the application to apply for the Love Your Block Grant Program for neighborhood engagement for the Community Development Department. **Vote 6-0**
- R-26-25** Resolution approving the application to apply for the STBG grant program in the amount of \$3,000,000 with the City providing \$600,000 in matching funds for the Connect Conway project. **Vote 6-0**

Ordinances Passed:

- O-26-33** Ordinance authorizing the issuance of taxable industrial development revenue refunding bonds for DBG located at 600 Dave Ward Drive. **Vote 6-0**
- O-26-34** Ordinance appropriating funds for the purchase of property located at the corner of Center and Robins Street in the amount of \$450,000 for the Parks & Recreation Department. **Vote 6-0**
- O-26-35** Ordinance authorizing personnel changes to reclassify one Engineer Senior Staff to Captain Basic Staff with no budget adjustment required within the Conway Fire Department. **Vote 6-0**
