On this date, the City Council of the City of Conway, Arkansas, met in regular session. Ordinances Passed:

- O-26-54** Ordinance appropriating funds to accept the low bid for Don Owen's Concession building for the Parks & Recreation Department and accepting the low bid from Stephen Hay Construction Inc. for \$2,589,771.50. *Amended to appropriate remaining \$589,771.50 only, from the A&P Fund Balance Account. **Vote 8-0***

- O-26-55** Ordinance appropriating funds in the amount of \$21,790.89 for the emergency replacement of an HVAC unit at District Court by Hayes Heating and Air. **Vote 8-0**
- O-26-56** Ordinance appropriating reimbursement funds from various entities for the Police Department. **Vote 8-0**
- O-26-57** Ordinance accepting grant proceeds for the Bomb Squad in the amount of \$267,500 from the Homeland Security Grant Program for the Fire Department. *Amended to include an emergency clause. **Vote 8-0***
Passed as amended. **Vote 8-0**
- O-26-58** Ordinance appropriating funds and insurance proceeds in the amounts of \$1,094 donation from Harp's, \$5,000 donation from Centennial Bank, and \$1,251 from Farmers Insurance. **Vote 8-0**
- O-26-59** Ordinance to approve the purchase of two fire engines through the HGACBuy Coop Purchasing Contract with Siddons-Martin in the amount of \$3,566,996 for the Fire Department. *Amended to include an emergency clause. **Vote 8-0*** Passed as amended. **Vote 8-0**
- O-26-60** Ordinance to rezone property located at 113 Conway Blvd from S-1 and R-2A to R-2. *Amended to approve S-1 zoning to R-2A. **Vote 8-0*** Passed as amended. **Vote 8-0**
