A RESOLUTION TO CALL A SPECIAL ELECTION ON NOVEMBER 3, 2026, TO FILL A VACANCY FOR CITY COUNCIL MEMBER FOR WARD TWO, POSITION ONE OF THE CITY OF CONWAY, ARKANSAS.

Whereas, a vacancy occurred for the position of City Council Member for Ward Two, Position Two on June 30, 2026; and

Whereas, pursuant to A.C.A. § 14-42-103(a)(2), the Conway City Council has voted to call a special election to fill the vacancy.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF CONWAY, ARKANSAS:

Section 1: That the Conway City Council, pursuant to A.C.A. § 7-11-105, hereby calls a special election to fill the vacancy for a Council Member in Ward Two, Position One of the City of Conway for November 3, 2026.

Section 2: That the Conway City Council hereby determines that the filing period for candidates seeking placement on the ballot for the special election shall be from noon on July 29, 2026, to noon on August 5, 2026.

All official petitions for municipal candidates shall be filed with the Faulkner County Clerk's Office during that period. The ballot position drawing shall occur on or before August 24, 2026, at the place and time designated by the Faulkner County Election Commission. The deadline to certify the General Election will be November 18, 2026.
