ORDINANCE

**City of Conway, Arkansas
Ordinance No. O-24-58**

AN ORDINANCE AMENDING SECTION 8.12.09 OF THE CONWAY MUNICIPAL CODE RELATING TO "TWO-HOUR" PARKING AND "THIRTY-MINUTE" PARKING; REPEALING ANY ORDINANCES IN CONFLICT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

Whereas, the public parking spaces in the city are for the benefit of the public; and

Whereas, the City has a strong interest in ensuring that members of the public have equal access to public parking spaces.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. That Section 8.12.09 of the Conway Municipal Code is hereby amended to include and add the updated section as follows:

8.12.09 - Parking zones.

C. No person or entity shall block, reserve, or otherwise prevent any person from access to any parking space in any public parking space including but not limited to those spaces in the two-hour and thirty-minute zones. The penalty for violations of shall be two hundred and fifty dollars (\$250) for the first offense and five hundred dollars (\$500) for any subsequent offense.

Section 2. All other provisions of Section 8.12.09 shall remain in effect.

Section 3. All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 4. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

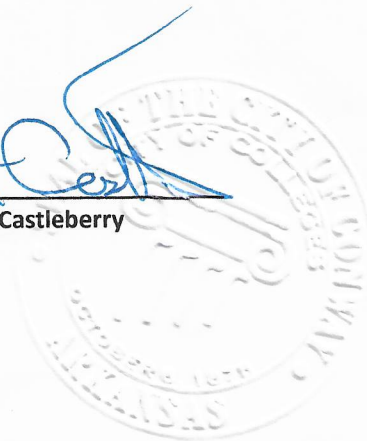
