

ORDINANCE NO. A-358

WHEREAS, a petition was duly filed with the City Council of the City of Conway, Arkansas, on the 23rd day of August, 1960, asking the City Council to vacate and abandon a certain alley lying within Block Forty-one (41), Robinson's Plan of the City of Conway, Arkansas, a more particular description of said alley being set forth in said petition and in Section One of this ordinance; and,

WHEREAS, attached to said petition is a certified copy of the portion of the plat filed in the office of the Recorder of Faulkner County, Arkansas, showing the said alley in said Block Forty-one (41), Robinson's Plan to the City of Conway, Arkansas, together with the lot numbers of each lot which abuts on the said alley hereinafter described; and,

WHEREAS, after due notice, as required by law, the Council has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question, and has ascertained that said alley hereinabove mentioned and hereinafter described has heretofore been dedicated to the public use as an alley, and has not been actually used by the public generally for a period of at least five years subsequent to the filing of the above mentioned plat and before the filing of the above petition; that all the owners of property abutting upon said alley sought to be vacated have filed with the City Council their written consent to such abandonment; and that the public interest and welfare will not be adversely affected by the abandonment of said alley;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION ONE (1). The City of Conway, Arkansas hereby releases, vacates and abandons all its rights, together with the rights of the public generally, in and to the alley lying within Block Forty-one (41), Robinson's Plan to the City of Conway, Arkansas, a more particular description of said alley being as follows:

Beginning at the Southeast corner of Lot One-A (1-A) of Jones-Smith-Wallace Replat of Lots One (1) and Two (2) of Firestone's Subdivision of Block Forty-one (41) of Robinson's Plan of the City of Conway, Arkansas, and run thence West One Hundred Thirty-five (135) feet to the Southwest corner of said Lot One-A (1-A); thence run South eighteen (18) feet and to the North line of Lot Eight (8) of Firestone's Subdivision of said Block Forty-one (41) of Robinson's plan of said City; thence run East One Hundred Thirty-five (135) feet to the Northeast corner of said Lot Eight (8); run thence North Eighteen (18) feet to the point of beginning;

SECTION TWO (2). A copy of this ordinance, duly certified by the City Clerk, shall be filed in the office of the Recorder of Deeds of Faulkner County, Arkansas.

SECTION THREE (3). This ordinance shall take effect and be in force from and after its passage and publication.
