

ORDINANCE NO. A- 401

AN ORDINANCE ESTABLISHING SEWER  
IMPROVEMENT DISTRICT NO. 3 OF CONWAY, ARKANSAS

WHEREAS, parties claiming to be more than two-thirds in value as shown by the last county assessment of the property located within the territory hereinafter described have filed a petition praying that an improvement district be established for the purpose hereinafter set out; and

WHEREAS, after due notice as required by law, the City Council of the City of Conway, Arkansas, has heard all parties desiring to be heard, and has ascertained that said petition was signed by more than two-thirds in value, as shown by the last county assessment, of the owners of real property situated within the said territory:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1. There is hereby established an improvement district embracing the following described property in the City of Conway, Arkansas:

Beginning at the Northwest corner of Section Thirteen (13), Township Five (5) North, Range Fourteen (14) West, approximately in the center of the intersection of Donaghey Avenue and Robins Street in the City of Conway, and run thence South along Donaghey Avenue a distance of Eight Hundred Forty (840) feet; thence East a distance of One Thousand Three Hundred Twenty (1,320) feet to a point which is Two Hundred Ten (210) feet South of the Southeast corner of Lot Twenty-four (24) of Block Seven (7) of College Oaks Addition to said City of Conway and is Forty-three and Five Tenths (43.5) feet East and One Hundred Eighty (180) feet South of the Southwest corner of the North One-half (N 1/2) of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section Thirteen (13); thence North a distance of Five Hundred Sixty (560) feet; thence East a distance of Four Hundred Thirty-five (435) feet to a point in the center line of Davis Street as shown on the replat of N. H. Ward Subdivision; thence North a distance of Two Hundred Eighty (280) feet to the center of Robins Street; thence West to the point of beginning;

for the purpose of constructing sewer collection lines to serve the inhabitants of the District, all to be located and constructed in the places and in the manner and of the materials that the Commissioners for said District, to be hereinafter appointed, shall deem for the best interests of the District.

Said District shall be known as Sewer Improvement District No. 3 of Conway, Arkansas, and Carl B. White, C. J. Robinson and Dale Thearl are hereby named Commissioners.

Section 2. This Ordinance shall take effect and be in force from and after its passage.
