AN ORDINANCE RE-ZONING CERTAIN PROPERTY IN THE CITY OF CONWAY, FAULKNER COUNTY, ARKANSAS AND DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

WHEREAS, the Conway Planning Commission has after notice and hearing recommended that the hereinafter described property be rezoned to these zones hereinafter designated and the City Council of the City of Conway, has determined that it is in the best interest of the said property to be re-zoned as hereinafter set forth.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That the following described properties be zoned as designated:

- a. The East 7/8 of the South  $\frac{1}{2}$  of the SE $\frac{1}{4}$  of Section 35, Township 6 North, Range 14 West, containing 70 acres more or less to be zoned R-1.
- b. Beginning at the SE corner of the Southeast Quarter (SE4) of the Northeast Quarter (NE4) of Section 15, Township 5 North, Range 14 West and running thence West 940 feet; thence North 350 feet; thence Northeasterly 320 feet; thence Southeasterly 875 feet; thence South 320 feet to point of beginning, as per attached drawing should be zoned R-1.
- c. Property in the Southeast Quarter (SE4) of Sec. 14, T5N, R14W, Faulkner County, Arkansas, to be annexed to the City of Conway: Part of the Southeast Quarter (SE4) of Sec. 14, T5N, R14W, Faulkner County Arkansas, described as follows: Beginning at the Northeast Corner of said Southeast Quarter (SE4) of Sec. 14, thence running West to the Northwest Corner of said Southeast Quarter (SE4) of Sec. 14; thence running South 522.7 feet; thence running East 2,262.8 ft. to a point 377.2 feet West of the East line of said Southeast Quarter (SE4) of Sec. 14; thence running South 797.3 feet to the South line of the Northeast Quarter (NE4) of the Southeast Quarter (SE4) of Sec. 14; thence running West 282.8 ft; thence running South 792. ft; thence running East 660 ft. to the East line of said Southeast Quarter (SE4) of Sec. 14; thence running North 2,112 ft., to the point of beginning. North 522.7 ft.; thence East 247.5 ft., to the point of beginning, should be zoned R-1.

Part of the W½, SE¼, of Section 13, T5N,R14W, Faulkner County, Arkansas, described as follows: Begin at the SW corner of said W½ SE¼, thence N-0-46-03-E, 2,333.38 feet, to the South right of way of State Highway No. 286 for a point of beginning, thence along said right of way S-64-57-42-E 462.84 feet; thence S-59-15-04-E 100.50 feet; thence S-64-57-42-E 100.00 feet; thence S-70-40-20-E 100.50 feet; thence S-65-00-20-E 667.48 feet; thence leaving said right of way S-0-54-55-W 419.45 feet; thence S-1-01-33-W 180.55 feet; thence in a Northwestwardly direction at the same angle up State Highway No. 286 to the west boundary line of said W½, SE¼, Section 13, T5N, R14W, thence N-89-22-56-W to the right of way of said State Highway no. 286 to the point of beginning should be zoned to B-3.

Tract No. 5: The North 413.16 feet of the Southeast Quarter (SE4) of the Southwest Quarter of Section 18, Township 5 North, Range 13 West, Faulkner County, Arkansas, except that land East of the Railroad right-of-way.

Tract No. 6: The East ½ of the Northwest Quarter (NW¼) of the Northwest Quarter (NW¾) of Section 19, Township 5 North, Range 13 West, Faulkner County, Arkansas, 20 acres.

Tract No. 7: The Northeast Quarter (NE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 13, Township 5 North, Range 14 West , 40 acres, all to be zoned I-3.

Section 2: It being necessary for the preservation of the public health, safety and welfare an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its passage and publication.
