

ORDINANCE NO. 79- 35

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: The City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on May 15, 1979, and said territory being situated in Faulkner County, Arkansas, and described as follows:

Part of the S 1/2 NE 1/4, Section 19, Township 5 North, Range 13 West, described as follows: From a point on the west right-of-way of Highway 365 which is 947 feet west of the southeast corner of said S 1/2 NE 1/4, run thence north 23 degrees west along said west right-of-way 469.0 feet to the point of beginning; thence continue along said west right-of-way line of Highway 365 north by 23 degrees west a distance of 210 feet; thence south 67 degrees west 251.1 feet to the east right-of-way of Missouri Pacific Railroad; thence south 23 degrees east along said east railroad right-of-way 210 feet; thence north 67 degrees east 251.1 feet to the point of beginning, containing 1.21 acre, more or less;

and that said above described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations, and regulations imposed upon the inhabitants within the original limits of said City of Conway, Arkansas.

SECTION 3: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; and that this ordinance shall

take effect and be in force from and after its passage and publication.
