

AN ORDINANCE ANNEXING TERRITORY TO WATER IMPROVEMENT DISTRICT #5 OF THE CITY OF CONWAY, ARKANSAS: DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, parties claiming to be the owners of the majority in assessed value of the property located within the territory hereinafter described have filed a petition praying that they be annexed into Water Improvement District #5 of the City of Conway; and,

WHEREAS, after due notice as required by law, the City Council of the City of Conway has heard all parties desiring to be heard, and ascertained that said petition is in all respects proper;

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:


Section 1. There is hereby annexed into Water Improvement District #5 of the City of Conway, Arkansas, the following described real property:

A part of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 35 Township 6 North, Range 14 West described as follows: beginning 267 feet West of the Southeast corner of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 35 T6N R14 W thence West 50 feet thence North 855 feet to the South boundary line of Highway No. 64 thence S88 degrees East along the South side of Highway No. 64 50 feet thence South 850 feet to the point of beginning containing (1) one acre more or less, and, a part of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 35 T6N R14W described as follows: beginning 317 feet West of the Southeast corner of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ thence West 225 feet thence North 865 feet to the South boundary of Highway No. 64 thence South 88 degrees East along the South side of Highway 64 225 feet thence South 855 feet to the point of beginning containing 4 $\frac{1}{2}$ acres more or less, and, a part of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ 35 T6N R14W described as follows: beginning 542 feet West of the Southeast corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ Section 35 T6N R14W thence West 100 feet thence North 870 feet to the South boundary line of Highway No. 64 thence South 88 degrees East along the South side of Highway No. 64 100 feet thence South 865 feet to the beginning containing 2 acres more or less.

For the purpose of constructing a water system to service said area.


Section 2. Said annexed area shall be in all respects governed by the existing laws governing Water Improvement District #5 to the City of Conway, Arkansas, and shall be served by the same commissioners, who shall compose the board of improvements for said district.
